



PAKISTAN SPATE IRRIGATION NETWORK - STRUCTURE AND COMPOSITION OF KPK NETWORK

Date of establishment 04 Oct 2013

Summary

The local spate irrigation network was established on October 4th 2013 at DI Khan KPK. In this regard a general meeting of the members was called in at local SPO Office DI Khan. 30 members of which the majority was nominated by the local partner organization have attended a workshop.

The proceeding started with the recitation of the holy Quran and followed by a round of introduction of the participants. The background and need of network was narrated by the Secretary of Spate Irrigation. The global scenario and scope of spate irrigation in Pakistan was highlighted and finally linked to the problems and practices of the local scenario at DI Khan and Tank Regions. The participates were informed that spate irrigation has considerable scope for further development in terms of getting higher yield through improved seeds, services and infrastructure improvements for sustainable livelihoods and poverty alleviation but the sector is neglected in the government mainstream spending. There are disputes within the farmers and different interest groups along the systems in Roud (River).

So, together and mainly through local networking we shall be able to raise the voices to the political and government high-ups as well as local government for system improvements in the region and elsewhere in Pakistan. They were further informed that the forum will be working jointly to represent spate irrigation as a whole in the region rather focusing on any certain system or issue. A joint meeting of the network would not only contribute to the strengthening of the network but will also highlight problems and record the issues of their area. The network will be maintaining the issues and problems of the each system separately and over the time.

The decisions and recommendations of the network towards the problem would be based on the merits. The network shall also be contributing their knowledge to the donor agencies and working professionals to acquire the sustainable and long term basis problem resolve. The network was informed that they should contribute for the water rights digitization, obtaining copies of the rights from relevant revenue departments and settlement of local issues, mainly water distribution and drinking water.

After the introduction and background detail, various positions of the executive body and general body were presented to the participants and merits, qualification and desired criteria were presented. They were informed who can contest to the executive body, future meetings, record keeping, preparation of the list of the issues on various spate systems at DI Khan and how the network secretary will maintain the records and press coverage. After the discussion, the nominations were obtained from the

participants and through hand show the election of the executive body was carried out. All the participants show their interest that a forum must be established that can further be fine tuned with the passage of time. Following the formal appointment, the papers were signed by the executive members and general body members.
